1. Workshop Style Discussion "What does the university's new structure mean to you?"

Noted:

- Scott Davidson was invited to discuss the evolution of the University structure into a
 college system. Faculties currently look after the quality of the academic experience but
 are a remote concept for students. The school structure will not change and will be the
 main point of reference for students.
- Colleges should help evolve the University's academic development.
 Colleges will establish their executives to mirror the executive board. The SU President has a seat on the Executive Board, so it is envisaged that there will a student seat on Executive Colleges.

The move to Colleges is experimental.

Discussed:

- Students were not really aware that there had been a change.
- There was some confusion about which courses were in which schools and which schools were in which faculties
- Concern was raised about the management of students joint across two schools/faculties/colleges.
- Students felt they had not been consulted and were concerned about the lack of communication and involvement.
- It was recognised that students will still be in daily contact with the same people
- Some Students feel this change is positive, and are pleased that their degree transcripts will show that they have studied in the College of Sciences /Arts/Social Sciences.
- There was some uneasiness about what the structure is evolving from and to, which was compounded by a lack of clarity about what the problems in the faculties were.
 Students would like to know whether:

There will be any administrative job losses?

What the costs are to the changeover?

What will happens to the disciplinary and other procedures /processes currently directed to Faculties?

5. Statement from the Board of Trustees

Noted:

- The Board are currently reviewing serious HR concerns within the Union
- This situation is taking up a great deal of Officer's time

- KT felt it appropriate to remind the Council of the Board's accountability to the Union, however due to the legalities of the situation confidentiality around this issue is essential currently.
- It is hoped to fill part-time posts in the by-elections to bring the officer team up to full complement

7. Student Open Session

Environmental Impact of The University

Noted:

- The University is currently ranked 47th for it's environmental impact
- The SU will invite students to become involved in the process of green impact

Action:

• The Welfare Officer and Dan Clayton have responsibility for environmental impact. KT to encourage students to participate.

Power Supply in Lecture Theatres

Noted:

- Students requested more power supplies in lecture theatres for students using laptops.
- JF to take forward to ICT but requested room numbers and examples of where supply could be improved as this would make the enquiry quicker to deal with.

Lectures finishing in timely manner

Noted:

• It was requested that Lecturers finished promptly at ten to the hour so Students are able to reach their next lecture in time

Action:

JF to use appropriate channels to remind Staff to finish on time

Mac's in the Library

Noted:

More Mac's were requested in the Library for Student use.
 This query is to be raised by Council with the University Librarian at Council in December

Student Question: "In the context of the Union's current difficulties and the President's additional seats on the Executive Board that can't be covered, and given the Code of Conduct that he signed, is the taking of photographs in the evening in clubs in Lincoln appropriate?"

Noted:

- Students discussed this question in groups
- There are two meetings that it is not possible to deputise: Board of Governors and Executive Board.

Discussed:

- Students were concerned that they were not notified that the president was on leave
- Students were concerned that the President could have interrupted his studies considering the situation at present. It was felt that his absence was not timely.
- Students less concerned about taking photographs in Clubs but some felt it might be a contravention of the Union's safe drinking stance if they were photographs of drunk students.
- Some Students felt that as this was done in his own time off it was his personal business, unless it brings the role or the Union into disrepute.
- Students felt that if the President was not being paid during his time off it would be reasonable to take on part time work.
- Council was concerned that the increased workload for the VP's may be too heavy.
- VP's confirmed that the absence was having a knock-on effect but that they were managing capably.

Action:

- Officers to find out if a deputy can attend meetings
- President to offer his own explanation to the next Council
